Compass Resorts has purchased Woodcrest Resort  
from the Colton Family!*

Compass Resorts is a company that was founded by brothers Kyle and Morgan Jenkin. Together with our team, we operate two other parks for a combined total of almost 800 sites. Our first park, Cedar Beach Resort, is our foundation and we are the fourth generation to run it. It has been in our family since 1929 and we are incredibly proud of its history. Purchase date of the park is September 30<sup>th</sup> 2021. Something important to note is that all current accounts held with Woodcrest will be handled by the Colton family. Once they issue your final hydro bill, they will apply your hydro deposit and you must collect any credits or settle outstanding balances with them.

Our plan for the remainder of the 2021 season and for 2022 is to run the park with as little disruptions as possible. We will use the season to assess what needs to be done, prioritizing future projects. We do see some aging infrastructure, along with some layout challenges that do need to be addressed. Our goal is to announce our action plan and timeline by July 2022. We will be as transparent and informative as possible in regards to our intentions for Woodcrest Resort.

In the meantime, we are putting a hold on any trailer sales in the park (new and used), as well as any new construction (like decks and sheds), other than for repairs to existing structures.

## **2022 RENEWALS...**

All 2022 renewals will need to be processed online and you can find instructions for this by visiting [www.woodcrestresort.ca](http://www.woodcrestresort.ca). Due to the nature of this transition year, please do not make payments at the Woodcrest office. All seasonal site fees for 2022 will be at a 10% increase from what you paid for 2021. Additional rates remain the same (docking, visitors, etc.). We are extending the deadline for renewals to take place from September 1<sup>st</sup> to 30<sup>th</sup>.
